

SUBJECT: AMENDMENT TO FUNDING AGREEMENT

DNR NEXT LEVEL TRAILS

DATE: DECEMBER 3, 2024

The city received funding through Indiana Department of Natural Resources for Next Level Trails funds in 2022. These funds were to be received for construction of the Nickel Plate Trail. Originally, \$3,130,000 was received for that project. Construction on the project was under original budget (approximately \$2,400,000) and DNR agreed that utilizing the remaining grant funds to begin design on a bridge over 146th Street was prudent.

That design work has begun as part of a separate contract signed late last year. However, the original grant agreement with DNR was set to expire at the end of 2024. This amendment to the funding agreement extends the end date to the end of 2025, allowing for that design work to continue and be reimbursed through the grant program.

I recommend the Board of Public Works approve the amendment to the funding agreement with Indiana DNR for Next Level Trails.

In advance, I greatly appreciate your consideration of this request.



AMENDMENT #1

CONTRACT #0000000000000000000065874

This is an Amendment to the Grant Agreement (the "Grant") entered into by and between the Indiana Department of Natural Resources/Division of State Parks (the "State") and CITY OF NOBLESVILLE (the "Grantee") approved by the last State signatory on 11/15/2022.

In consideration of the mutual undertakings and covenants hereinafter set forth, the parties agree as follows:

The Grant is hereby amended as follows:

- 1. The Grant is hereby extended for an additional period of one (1) year and thirty (30) days. It shall terminate on 12/31/2025.
- 2. The consideration during this extension period is zero (\$0.00) dollars. Total remuneration under the Grant is not to exceed \$3,130,000.00.

All matters set forth in the original Grant and not affected by this Amendment shall remain in full force and effect.

Non-Collusion, Acceptance

The undersigned attests, subject to the penalties for perjury, that the undersigned is the Grantee, or that the undersigned is the properly authorized representative, agent, member or officer of the Grantee. Further, to the undersigned's knowledge, neither the undersigned nor any other member, employee, representative, agent or officer of the Grantee, directly or indirectly, has entered into or been offered any sum of money or other consideration for the execution of this Amendment other than that which appears upon the face hereof. Furthermore, if the undersigned has knowledge that a state officer, employee, or special state appointee, as those terms are defined in IC § 4-2-6-1, has a financial interest in the Amendment, the Grantee attests to compliance with the disclosure requirements in IC § 4-2-6-10.5.

Agreement to Use Electronic Signatures
