

Please find attached the PowerPoint that Keep Noblesville presented at the December Roads Committee Meeting. As you can see, they are continuing to accomplish beautification projects throughout the City. I am requesting approval to submit for payment their \$10,000 Public Purpose Grant.

I recommend the Board approve this payment.





Keep Noblesville Beautiful (KNB) is a non-profit community improvement organization dedicated to enhancing Noblesville's natural beauty through a variety of service projects and educational programs. It provides design input on city project initiatives when appropriate. KNB is modeled after the Keep America Beautiful model and draws significant inspiration from Keep Indianapolis Beautiful.

Keep America Beautiful

A leading national nonprofit, Keep America Beautiful inspires and educates people to take action every day to improve and beautify their community environment. We envision a country in which every community is a clean, green, and beautiful place to live.

KNB has adapted its mission to meet the specific needs of the community through a grassroots approach to community involvement and engagement. Our ongoing evolution also includes an evaluation of the four pillars of Mayor Jensen's administration.

Comprehensive Workforce & Economic Development

Community development equals economic development. KNB facilitates opportunities, support, coordination and equipment for corporations and school groups to connect to neighborhoods and the greater community to fulfill "day of service" or philanthropy missions. KNB also provides project opportunities during Serve Noblesville's week of service.

Public Health & Safety

The mental health benefits of spending time outside and volunteering are very well-documented. KNB programs provide opportunities for increased mental and physical well-being. In addition, beautification projects create a sense of pride and can help to reduce crime, particularly property crime.

Downtown, Culture & Recreation

Downtown beautification projects are top priority and have included a partnership with the Parks Department for green space improvements at Federal Hill, Forest Park and Riverside Cemetery.

Roundabout art sculptures add to the public art and culture inventory in Noblesville. KNB partners with Indiana Peony Festival to assist with plantings along the expanding Peony Trail.

Roads & Infrastructure

KNB annually spearheads Highway 37 clean-ups along a two-mile stretch including volunteer coordination, tools and equipment. There has been a significant reduction in litter along this corridor since the launch of this program in 2010. KNB was a key partner for the review of RFP's and selection on the Roundabouts Beautification Team. KNB's ongoing art initiative includes installation of art in several of these roundabouts.

Thank you for the on-going support from the City of Noblesville and the opportunities this Public Purpose Grant provides KNB to expand its mission and community engagement.

Memorandum of Understanding - 2025 Grant Request

Scope of Work:

- Facilitate public art in the City of Noblesville and coordinate with other arts groups
- Support green space improvements at Federal Hill, Midland Trace Trailhead, Riverside Cemetery
- Coordinate roundabout design and installation with the city
- Increase flower plantings and enhancements (formerly city gateways) with Indiana Peony Festival
- Lead Highway 37 clean-up projects
- Provide Serve Noblesville volunteer opportunities and coordination
- Collaborate with groups to install and maintain public gardens
- Distribute native plants seeds and educate the public on installation and sustainability
- Write grants or provide support for grants, seeking funding for beautification projects

Deliverables for 2025:

- Coordinate one new roundabout art project
- Install one new public art project or support another group's efforts
- Collaborate with Roundabouts Beautification Team on design and other ROW beautification projects
- Generate and lead 1-2 Serve Noblesville projects
- · Coordinate the installation of artistic wraps on available utility boxes
- Conduct 3 Highway clean up projects
- Provide an educational program to the public promoting the importance of pollinator plants
- Initiate annual and/or ongoing fundraiser

Keep Noblesville will also:

Connect with local, government, arts community and regional stakeholders in order to shape Noblesville's Cultural Arts strategy for long-term sustainability and success. Stakeholders include but are not limited to:

Funding:

KNB conducts two fundraising mailings per year, producing \$8,735.15 for 2024.

We received the generous \$10,000 Public Purpose Grant from the City of Noblesville.

The total income for KNB for 2024 was \$18,735.15. Total in-kind contributions included \$4,681.35 (NSD for Sea Oats and Butterflies, GKM for daffodil pull, Love Your Landscape for Riverside Cemetery design and delivery of material, Martin and Martin Insurance Agency for mailing expenses). KNB will continue to

pursue grant opportunities for specific art and beautification projects. Total expenses for 2024 are estimated at \$21,535.42.

Schedule:

If approved, payments in the amount of \$10,000 could be made to Keep Noblesville Beautiful upon approval of this agreement.


