ORDINANCE NO. 02-01-25  
ADDITIONAL APPROPRIATION ORDINANCE

108 PARK FUND

WHEREAS, certain fiscal demands have developed since the adoption of the current Civil City annual budget so that it is now necessary to add appropriation authority from available unappropriated reserve balance in a fund.

WHEREAS, Indiana state law requires local units of government to report their proposed budgets, itemized by appropriated fund, for each new fiscal year to the Indiana Department of Local Government Finance (DLGF) prior to adoption by the local governing body.

WHEREAS, the 2025 Civil City budget, adopted through passage of Ordinance 56-09-24 on October 29, 2024, included an appropriation of \$1,608,000 from the Park Fund (Fund 108) commensurate with the strategic spenddown of available cash reserves for one-time capital projects and a small correction to the across-the-board pay adjustment for employees paid from the fund.

WHEREAS, the amount reported to the DLGF, as the proposed budget appropriation, inadvertently excluded that amount for the Park Fund.

WHEREAS, since the 2025 adopted budget appropriation amount for the Park Fund exceeded the 2025 proposed budget appropriation amount, the DLGF reset the approved appropriation to the lower amount in the City's 2025 Budget Order under requirements set forth in Indiana state law.

WHEREAS, to reconcile that discrepancy, the City Council must now re-appropriate the amount of the difference to restore the total appropriations in the Park Fund to the amount it had previously approved in the 2025 adopted budget to comply with DLGF certification requirements.

NOW, THEREFORE, to address such demands for the Park Fund:

Section 1. BE IT ORDAINED, by the Common Council of the City of Noblesville, Indiana, that, for the obligations of the Civil City, the following appropriation increase be executed:
