The total project cost is estimated at \$7,680 with a maximum grant of \$3,840 and additional contingency of \$1,000 pending any unforeseen issues. This particular application is for replacement of awnings, repainting of exterior trim, doors and decorative features.

After completion, all façade improvements must be inspected by the Program Administrator to verify work has been completed according to the Façade Improvement Agreement. "After" photos and paid invoices itemizing all eligible costs will be submitted to the Mayor's Office for verification. After all work has been completed and verified, funds will be disbursed.

#### Current Condition of the Building

The Miller Surveying Building needs updating. The Current conditions of the 5 window awnings are torn and very weathered, which will be replaced.

The wood window trim and seals are faded and need repainted.

The rod iron work around the front door and on the second story windows are rusting and needs wire brushed and re-painted.

The back door and garage door will be re-painted.

The wood above the garage door is rotten and will be replaced and painted.





## Detailed Project Plans and Specifications

The existing awning above the windows will be removed, brought to the shop, recovered and installed in the original positions. The fabric will be the same color as the original.

The rod iron on the front of the building will be scaped and re-painted with flat black exterior paint. All exterior wood trim will be scraped, calked and re-painted with the original color scheme.


