Chief Eddingfield presented three new proposed hires for the recruit class which will start August 7, 2023. All three are pending their INPRS approval. They are Craig Costlow, Michael Lyons, and Nicholas Golab.

Commissioner Goddard asked if they are the next individuals on the hiring list. Chief Eddingfield said they are.

Commissioner Goddard asked how the hiring process is going regarding the number of applicants we want to hire. Chief Eddingfield said we have fifteen SAFER grant hires plus an additional eight on top of that for 23 total. He said we are also trying to capture four vacancies that we have through retirements this year, which would be a total of 27. Chief Eddingfield said if today's three new hires and one lateral transfer are all approved and they are all approved by INPRS, then we will have 25. He said we lost two applicants this week due to the medical board and we are out of time, so we will not be able to replace those two in time for the August 7 recruit class start. Commission Goddard asked if this would affect the SAFER funding and Chief Eddingfield said no, that the funding for the fifteen SAFER hires are confirmed.
