Guardian Environmental Products, Inc. is pleased to offer the following proposal. Guardian Environmental proposes to supply and deliver the following equipment in accordance with the Conditions of Sale attached as part of this proposal.

Scope of supply:

Under this item the Guardian Environmental Products shall furnish and deliver ready for installation, chain and scraper type sludge collecting equipment per the following detail description.

ROTARY SCUM REMOVAL EQUIPMENT

Each Rotary Scum Pipe will include slotted pipe with 60-degree openings separated by 2 inch stiffening bands, fabricated end supports with UHMW-PE bearings, seals, and wall gaskets. All fabrications will be 304 stainless steel with 316 stainless steel hardware and concrete anchors.

Scum pipe can be manually rotated by means of a 1-1/2" pipe lever actuator extending approximately 48" above the operating deck for ease of operator access. Sum pipe

rotation shall allow floated material to flow over the tipped edge and into the pipe. Floated scum will flow by gravity to adjacent scum pit for removal by others.

The equipment shall be as manufactured by Guardian Environmental Products, Inc.

GENERAL DESCRIPTION

Rotary Scum Removal equipment shall include:

- Scum pipe 14" diameter x 15' long
- Lever arm actuator, 1-1/2" diameter x approx. 6 ft long
- End bearings and housing, fabricated with UHMW bearing and packed seals
- Wall gaskets, 1/2" neoprene
- Anchor and assembly hardware, 316 ss.

OPTIONAL DEDUCT:

The above quoted equipment is 304 schedule 10 stainless steel. Alternate to provide A35 carbon steel epoxy painted in lieu of 304ss: **Deduct \$4,800**

ERECTION INFORMATION: Equipment will be shipped loose for assembly by others. Contractor shall receive and assemble components with all hardware supplied. Anchor hardware for wall bearings will be provided and mounted by contractor in accordance with the manufacturer's recommendation.

Heaviest piece: Scum pipe with end bearings, 500 lbs

QUOTATION VALID: This quotation is valid for a period of Forty-five (45) days unless extended in writing.

PAYMENT AND PRICE TERMS: The terms of payment are:

- 10% of the gross amount upon acceptance of approved submittals.
- 80% of the gross amount after delivery or offer to deliver.
- 10% of the gross amount upon start-up inspection or upon first beneficial use of the equipment, whichever occurs first, but in no event later than one hundred twenty (120) days following shipment.

These terms are completely independent from and in no way contingent upon when the contractor receives payment from the Owner or prime contractor. Any partial shipment will be subject to these same payment terms. Guardian Environmental Products, Inc. reserves the right to ship, invoice and collect for partial shipments. Any past due payments will be subject to a charge of 1.5% per month on the unpaid balance until payment is received and current.

EXCLUDED:

Our price does not include any other system accessories not specifically listed in this proposal. Prices do not include sales, use, excise or other similar taxes unless expressly stated in this quotation.

Specific exclusions include the following:

- No Weirs or Troughs
- No ladders, platforms, or railing
- No sludge pumps or associated piping

SCHEDULE:

Four to six (4-6) weeks for submittals after acceptance of order.

Eight to twelve (8-10) weeks for delivery of equipment after receipt of approved submittals and release to fabricate.

SERVICE:

Our price includes the services of a factory field serviceman for one (1) trip and one (1) days at the site. Additional services can be purchased on a per diem basis as stated in Conditions of Sale of this proposal.
