Urban Forester Report Noblesville Tree Board Meeting: June 5, 2023

- 1. About 169 of 170 new Street Trees have been installed by BrightView. In the course of this operation 2 trees were "lost" and not planted. They planned to purchase 2 replacement trees and install them, but only 1 of the 2 was installed.
- 2. There are about 50 tree stumps remaining in Woods and Greens at Prairie Crossing subdivision to be removed for the sidewalk repair project there. To my knowledge, this is the final such project remaining for 2023. I hope to return to existing work orders for tree removals, stump grindings and tree pruning by the middle of this month.
- 3. We have run into some issues with private irrigation lines being installed on City property, and then being subsequently damaged by stump removal or tree planting operations. Going forward, the planting of new street trees in areas where private irrigation has been installed, will not be approved without the appropriate homeowner signing off the City of Noblesville from liability damage to such systems.
- 4. I have met with HOA leadership and cruised several subdivisions with concerns about subdivision-wide street trees: Retreat at Mill Grove, Wellington Northeast, Pebblebrook Villas, Cranbrook, Stony Creek Estates.
- 5. I began sending out a monthly info sheet to HOA and Property Management group representatives with information regarding street trees. April: Volcano Mulch, May: HOA's have no jurisdiction over City ROW. June: Irrigation encroachment on ROW's.
- 6. I am seeking documentation from the City which requires residents to maintain the City ROW in front of their property. I have had a handful of folks pushing back against this.
