### **Old Business:**

Tree Planting Grant Program:

Planning for this continues. The draft documents have been prepared & submitted to the city for review. City legal is reviewing. Discussed online submittal process and potential for allowing paper form submittal to the urban forester. The next steps are:

- 1. The city to review the program documents.
- 2. Developing the metrics (point system or grant grading matrix) to prioritize projects for awarding grants. Grant Grading Matrix to include "need" as part of decision point system (to ensure that trees given will go to those who have the greatest financial need for them).

# UDO Revision and Tree Preservation/iTree:

Previously, there was a discussion about what items the tree board could contribute (if a conversation with city agencies occurs about potential Unified Development Ordinance (UDO) update). The goal is to come up with ideas that could solve current problems regarding tree planting & maintenance as well as increase efficiency of city operations. A list of items will be compiled by this board and presented to city staff (in a lunchtime, collaborative meeting) for further discussion.

This meeting has been tentatively scheduled for the month November, with a final date to be sent soon.
