BOARD OF PUBLIC WORKS AND SAFETY CITY OF NOBLESVILLE DECEMBER 19, 2023

The Board of Public Works and Safety met in regular session on Tuesday, December 19, 2023 in the Council chamber. President Jack Martin called the meeting to order at 9:00 a.m. pursuant to public notice with the following members present: John Ditslear, Laurie Dyer, and Rick Taylor. Robert Elmer was absent.

Also present were City Clerk Evelyn Lees, Deputy Mayor Matt Light, Deputy Clerk Christina Adamson, Public Safety Director Chad Knecht, City Attorney Jonathan Hughes, Department Directors, staff, representatives of bidders, and interested citizens.

PLEDGE OF ALLEGIANCE

Mr. Martin led the chamber in the Pledge of Allegiance.

PETITIONS OR COMMENTS BY CITIZENS WHO ARE PRESENT

There were no comments.

APPROVAL OF AGENDA

Mr. Taylor moved to amend the agenda to add New Item for Discussion #5A, Board to Consider Temporary Closure of Two Parking Spaces at 977 Logan Street for Dumpster Placement (René Gulley), second Ms. Dyer as amended, five aye, motion carried.

BID OPENING: DESIGN AND MANUFACTURE OF DIGEST MIXERS/NOBLESVILLE UTILITIES: WASTEWATER TREATMENT PLANT

Mr. Hughes stated the first bid was from DXP Enterprises, Inc. d/b/a Sullivan Environmental Technologies. A non-collusion affidavit and financial statement were included in the packet. The E-verify affidavit was not apparent. Because this is a purchase, a bid bond and Form 96 were not required. They acknowledged receipt of addenda one, two, and three. Their base bid was \$348,805.00.

The next bid was from Olympus Technologies, Inc. A non-collusion affidavit, E-verify affidavit, and bid bond were included in the packet. They acknowledged receipt of addenda one and two. Their base bid was \$264,320.00.

Mr. Hughes stated that appeared to be all the bids for the Design and Manufacture of Digest Mixers/Noblesville Utilities: Wastewater Treatment Plant. He asked if anyone present knew of any other bids. Seeing none, he recommended referring the bids to the Utilities Department for review and recommendation. Mr. Martin so moved, second Mr. Ditslear, five aye, motion carried.

Mr. Taylor moved to approve the consent agenda as presented, second Mr. Ditslear, four aye, motion carried.

NEW ITEMS FOR DISCUSSION

#1 BOARD TO CONSIDER 2024 SERVICE AGREEMENT WITH THE HUMANE SOCIETY FOR HAMILTON COUNTY (ASSISTANT CHIEF BRAD ARNOLD)

Assistant Police Chief Brad Arnold wished a Merry Christmas to everyone present. He stated the 2024 agreement with the Hamilton County Humane Society is for the shelter and care of animals surrendered by Noblesville residents and Noblesville police officers. He stated the agreement pays for medical care and housing for the animals for seven days. He stated this year's agreement is for \$223,246.39, which is a ten percent increase over the 2023 agreement. He stated the Humane Society's costs decreased slightly, but animal drop-offs increased. He stated almost 154 animals are projected to be surrendered in 2024. He stated the number county-wide has increased by 19 percent. He stated Fishers and Westfield are higher. Mr. Taylor moved to approve the 2024 service agreement with the Humane Society for Hamilton County, second Ms. Dyer, five aye, motion carried.

#2 BOARD TO CONSIDER CAMERA SERVICES AGREEMENT WITH FLOCK GROUP INC. FOR THE POLICE DEPARTMENT (ASSISTANT CHIEF BRAD ARNOLD)

Assistant Police Chief Brad Arnold stated this agreement will provide 11 additional fixed-site Flock license plate reader cameras. He stated the cameras have been in use for several years and are used in a variety of ways. He stated the cameras scan vehicles and license plates. He stated they are used to watch for stolen cars and silver and amber alerts, as well as for investigations. He stated the Police Department has had great success with the cameras. He stated this agreement will increase the number of cameras from seven to 18. He stated the contract for five years is a total of \$229,150.00. He stated the agreement has a first-year cost of \$49,150.00, then \$45,000.00 per year for the next four years at \$2,500.00 per camera per year. There was a discussion concerning the cameras' capabilities. Mr. Elmer moved to approve the camera services agreement with Flock for additional cameras, second Mr. Ditslear, five aye, motion carried.

#3 BOARD TO CONSIDER 2024 MENTAL HEALTH CONSULTANT SERVICE AGREEMENT WITH THE POLICE DEPARTMENT (DEPUTY CHIEF JASON THOMPSON)

Deputy Police Chief Jason Thompson stated this request is the 2024 Mental Health Consultant services agreement between the Noblesville Police Department and Susan Sherer-Vincent. He stated as part of the comprehensive mental health initiative established at the police department, Susan Sherer-Vincent provides numerous services to the members of the department, which are outlined in Attachment A to the agreement. He stated the service agreement is for \$90,000.00, and funding is in the 2024 budget. He stated Ms. Sherer-Vincent has worked with the department for almost a decade. He stated her interactions with the department have increased due to the department's growth and younger officers seeking her services to establish a baseline. He stated the stigma surrounding mental health services has lessened. He stated she has also added a social worker to assist her. He stated she is also assisting the NobleAct program as it grows. He stated she is on call 24 hours per day and makes the department better. The contract will terminate on December 31, 2024 at a cost not to exceed \$90,000.00. Mr. Ditslear moved to approve the 2024 mental health service agreement, second Mr. Elmer, five aye, motion carried.

#4 BOARD TO CONSIDER AGREEMENT WITH ARTISAN OUTDOOR CRAFTSMAN FOR FOREST PARK LODGE DECK REPLACEMENT (BRANDON BENNETT)

Parks and Recreation Director Brandon Bennett stated this agreement with Artisan Outdoor Craftsman is for replacement of the deck at Forest Park Lodge. He stated four quotes were solicited, and Artisan Outdoor Craftsman was the lowest responsive, responsible quoter at \$100,894.00. He stated the work will be performed in the spring. Mr. Elmer moved to approve the Forest Park deck replacement, second Mr. Taylor, five aye, motion carried.

#5 BOARD TO CONSIDER TEMPORARY SIDEWALK, PARKING SPACES, AND ALLEY CLOSURES FOR WINDOW REPLACEMENT AT 954 CONNER STREET (RENÉ GULLEY)

Street Department Operations Manager René Gulley stated Hometown Window & Door requested permission to use two parking spaces and block the sidewalk in front of 954 Conner Street for window replacement with a boom lift. She stated once the front windows are replaced, they will move the boom lift into the east/west alley to replace the windows on the back side of the building. She stated they hope to start in the alley this week. She stated during evening hours the boom lift will be placed in the parking spaces behind 948 Conner Street to allow access to the alley. Mr. Elmer moved to approve the temporary sidewalk closure, second Ms. Dyer, five aye, motion carried.

#5A BOARD TO CONSIDER TEMPORARY CLOSURE OF TWO PARKING SPACES AT 977 LOGAN STREET FOR DUMPSTER PLACEMENT (RENÉ GULLEY)

Street Department Operations Manager René Gulley stated Mina Starsiak Hawk and her team will be performing demolition on their new space at the Logan Village Mall and would like to set a dumpster in front of 977 Logan Street. She stated the work will consist of fixtures only, and no changes will be made to mechanical, electrical, or plumbing. She stated the request is for 30 days, but the dumpster will be removed as soon as possible. She stated they hope to start as soon as possible. Mr. Elmer moved to approve the dumpster placement at 977 Logan for up to 30 days, second Mr. Taylor, five aye, motion carried.

#6 BOARD TO CONSIDER CONTRACT RENEWAL WITH ENVIRONMENTAL SYSTEMS RESEARCH INSTITUTE, INC. FOR GEOGRAPHIC INFORMATION SYSTEM (GIS) TECHNOLOGY (MISTY SHEARER, MIKE MORRIS)

Systems Administrator Misty Shearer stated the City has had a contract with ESRI since 2001. She stated the mapping software ties into the CityWorks software. She stated ESRI is used for maps to look up addresses, for utilities, for planning permit software, and data analytics. She stated this contract is for a three-year renewal. The contract will terminate on December 31, 2026 at a total cost not to exceed \$175,500.00, to be paid at \$58,500.00 per year. Mr. Elmer moved to approve the renewal of Environmental Systems Research for the GIS services, second Mr. Ditslear, five aye, motion carried.

#7 BOARD TO CONSIDER ANNUAL RENEWAL OF CITYWORKS SOFTWARE LICENSING AGREEMENT (MIKE MORRIS)

GIS Coordinator Mike Morris stated the City has used CityWorks software, which has been used as the assets management program since 2014. He stated it is time to renew the licensing agreement. The contract will terminate on December 31, 2024 at a total cost of \$76,972.90. Mr. Taylor moved to approve the annual renewal of CityWorks software license agreement, second Mr. Ditslear, five aye, motion carried.

#8 BOARD TO CONSIDER PURCHASE OF THREE REPLACEMENT PUMPS FOR LIFT STATION #2 (JONATHAN MIRGEAUX)

Utilities Director Jonathan Mirgeaux stated the Lift Station 2 project is the largest capital project for the Utility since he joined the City, and there are concerns about the design. He stated the lift station overall is in good shape, but the pumps are at the end of their useful life and must be replaced. He stated there are also issues with capacity and clogging. He stated his long-term preference is to have gravity sewer rather than the lift station, but more research is needed. He stated three quotes were solicited, and the lowest responsive, responsible quote was from Hidrostal for \$149,089.00. He stated the lowest quote was for higher capacity pumps with cutting heads for better operation. He stated replacing the pumps will give the Utility time to evaluate if a gravity sewer will work. Mr. Elmer thanked Mr. Mirgeaux for his work and care to spend the City's money in the best way possible. Mr. Ditslear moved to approve the purchase of three replacement pumps for Lift Station #2 as presented, second Mr. Taylor, five aye, motion carried.

#9 BOARD TO CONSIDER PURCHASE OF EIGHT REPLACEMENT ROTARY SCUM SKIMMER TROUGHS FOR THE WASTEWATER TREATMENT PLANT (JONATHAN MIRGEAUX)

Utilities Director Jonathan Mirgeaux stated this request is to purchase scum skimmer troughs for the wastewater treatment plant to replace skimmer troughs that are heavily rusted and corroded. He stated the new skimmer troughs are made of stainless steel and will have a much longer life. He stated three quotes were solicited, and Guardian Environmental Products was the lowest

responsive, responsible quoter at \$97,645.00. Mr. Ditslear moved to approve, second Ms. Dyer, five aye, motion carried.

#10 BOARD TO CONSIDER PROFESSIONAL SERVICES AGREEMENT WITH KIMLEY-HORN AND ASSOCIATES, INC. (EN-380) (JIM HELLMANN)

Assistant City Engineer Jim Hellmann stated the last Downtown parking study was conducted over seven years ago, only collecting data in the daytime. He stated this study will use Denison Parking's data as well as studying evening and weekend parking. He stated the study also will include areas east and west of White River, 8th and 9th Streets, and the new Pleasant Street corridor. He stated this new study will include extra parking and financial metrics for future use. He stated Kimley-Horn has offices in Indianapolis, Chicago, and Columbus, Ohio. The contract will terminate on December 31, 2024 at a cost not to exceed \$140,000.00. Mr. Elmer moved to approve the professional services agreement with Kimley-Horn, second Mr. Taylor, five aye, motion carried.

#11 BOARD TO CONSIDER AGREEMENT WITH ETICA GROUP FOR ON-CALL ENGINEERING AND CONSULTING SERVICES (EN-339-01) (ANDREW RODEWALD)

Engineering Project Manager Andrew Rodewald stated this on-call contract with Etica Group will update an existing contract. He stated Etica performs safety studies and traffic impact studies. The contract will terminate on December 31, 2026 at a cost not to exceed \$100,000.00. Mr. Ditslear moved to approve, second Mr. Elmer, five aye, motion carried.

#12 BOARD TO CONSIDER AMENDMENT NO. 1 TO THE ON-CALL
AGREEMENT WITH CHRISTOPHER B. BURKE ENGINEERING, LLC (EN323-03) (ANDREW RODEWALD)

Engineering Project Manager Andrew Rodewald stated this supplemental contract adds terms and fees to the original contract to include work on drainage and help with the Municipal Separate Storm Sewer System (MS4) program. The agreement will terminate on December 31, 2025 at a cost not to exceed \$75,000.00. Mr. Elmer moved to approve the supplemental with Christopher Burke, second Ms. Dyer, five aye, motion carried.

#13 BOARD TO CONSIDER CHANGE ORDER NO. 1 WITH INDOT FOR THE STATE ROAD 38 AND OAKMONT/WHITCOMB RIDGE ROUNDABOUT (ANDREW RODEWALD)

Engineering Project Manager Andrew Rodewald stated in 2019 the City entered into an agreement with INDOT to equally share costs to construct three roundabouts. He stated one of the roundabouts is at State Road 38 and Oakmont Drive/Whitcomb Ridge. He stated additional tree clearing was needed in the spring for utility relocation, resulting in a change order. He stated the City is allowed to vet change orders for the project. He stated half of the cost of this change order is invoiced to the City by INDOT in the amount of \$9,431.90. Mr. Taylor moved to approve Change Order No. 1 with INDOT for the State Road 38 and Oakmont/Whitcomb Ridge Roundabout, second Ms. Dyer, five aye, motion carried.

#14 BOARD TO CONSIDER RELEASE OF BEST MANAGEMENT PRACTICE (BMP) EASEMENT AT 14098 BERGEN BOULEVARD (ODISE ADAMS)

Engineering Project Coordinator Justin Hubbard spoke on behalf of Odise Adams. Mr. Hellmann stated the site of the Chick-fil-A in the Saxony Corporate Campus previously had two BMP easements, but due to drive-through lane and canopy construction in 2022 and 2023, the stormwater sewer was reconstructed to leave only one BMP. He stated the property owner has requested release of the easement that no longer contains a BMP. Mr. Ditslear moved to approve the release of Best Management Practice Easement at 14098 Bergen Boulevard, second Ms. Dyer, five aye, motion carried.

#15 BOARD TO CONSIDER APPLICATION OF ROAD IMPACT FEE CREDIT FOR VREC III – MILHAUS RIVERWEST, LLC (JUSTIN HUBBARD)

Engineering Project Coordinator Justin Hubbard stated the road impact fee agreement with the developer of RiverWest at the northwest corner of 146th Street and River Road was approved at the February 14, 2023 meeting. He stated the developer agreed to complete improvements identified in the Road Impact Fee Zone Improvement Plan Study in exchange for \$500,000.00 in road impact fee credits. He stated the agreement allows RiverWest to give the credits to developers within their project. He stated this application grants road impact fee credits of \$226,795.20 to VREC III-Milhaus RiverWest, LLC to be applied upon issuance of the building permit for a multi-family project to be known as Lavina at RiverWest. He stated a total of \$273,204.80 in credits will remain. Mr. Elmer moved to approve the road impact fee credit for VREC III-Milhaus RiverWest, LLC, second Ms. Dyer, five aye, motion carried.

#16 BOARD TO CONSIDER APPLICATION OF ROAD IMPACT FEE CREDIT FOR HIGHGROUND NOBLESVILLE I, LLC (JUSTIN HUBBARD)

Engineering Project Coordinator Justin Hubbard stated this application grants road impact fee credits of \$175,024.00 to Highground Noblesville I, LLC to be applied upon issuance of the building permit. He stated a total of \$98,180.80 in credits will remain. Mr. Taylor moved to approve the application of road impact fee credit for Highground Noblesville I, LLC, second Mr. Ditslear, five aye, motion carried.

#17 BOARD TO CONSIDER APPLICATION OF ROAD IMPACT FEE CREDIT FOR PULTE GROUP (JUSTIN HUBBARD)

Engineering Project Coordinator Justin Hubbard stated this application grants road impact fee credits of \$98,180.80 to Pulte Group to be applied upon issuance of the building permit, which leaves a \$0 balance of road impact fee credits. Mr. Taylor moved to approve the application of road impact fee credit for Pulte Group, second Mr. Ditslear, five aye, motion carried.

Mr. Elmer wished everyone a Merry Christmas.
