The first is Kevin Hast who is currently in the recruit class of the Zionsville Fire Department and is already in PERF so this would be a transfer to move him to NFD. We are planning on a

scheduled hire date of November 29, 2021. The second proposed hire is Randall Weaver who is in the recruit academy at West Lafayette. We still have to polygraph him, so this would be an approval of Randall pending a successful polygraph examination. He is also already in PERF and would also be a transfer to NFD. His planned hire date would also be November 29, 2021.

Chief Mitchell said we are down three (3) members now and Hast and Weaver would be replacing two (2) of those members.
