

PROJECT SUMMARY

Mundy Realty is seeking the re-zone of approximately 24 acres between S.R. 32 and S.R. 38 at the terminus of River Road in order to build a retail shopping center that will include a new 55,000 square foot Marsh supermarket. In addition to the supermarket, the main complex of the center is planned to include another retail anchor (between 75,000 and 80,000 sq. ft.) and a number of smaller tenant spaces for business use (approximately 20,000 square feet). There are also five outlots, four on the south end along S.R. 32, and one at the north end on S.R. 38.

A significant feature of the proposed preliminary development Plan is the extension of River Road from S.R. 32 to S.R. 38, which will complete an arterial connector proposed by the component of the Noblesville Comprehensive Plan. Completion of this component of the Thoroughfare Plan should help relieve congestion at the intersection of State Road 38 and State Road 32. Additionally, much more convenient and efficient access will be available to River Road for traffic originating in the "Harbours" developments.

The supermarket will bring Noblesville to the "Next Generation" of grocery retailing. The size of the store (20,000 sq. ft. larger than the existing Marsh store) will allow a product mix with up to one third fresh goods including poultry, meat, seafood, produce, bakery and Deli products and prepared foods.

The total project (exclusive of inventory) represents an investment of almost \$6,000,000 and is reflective of a Marsh/Mundy view that the City of Noblesville is ready for a substantial forward.
