AN ORDINANCE AMENDING THE UNIFIED DEVELOPMENT ORDINANCE NO. 62-12-95, ORDINANCE NO. 3-1-96 TOWN AND COUNTRY PLANNED DEVELOPMENT ORDINANCE, AND ALL AMENDMENTS THERETO, A PART OF THE COMPREHENSIVE MASTER PLAN FOR THE CITY OF NOBLESVILLE, HAMILTON COUNTY, INDIANA

An Ordinance to amend the Unified Development Ordinance and Ordinance No. 3-1-96, and all amendments thereto for the City of Noblesville, Hamilton County, Indiana, enacted by the City of Noblesville under the authority of Chapter 174 of the Acts of the Indiana General Assembly 1947, as amended, and

WHEREAS, the Plan Commission of the City of Noblesville has conducted a public hearing on Application No. 000135-2016 as required by law concerning waivers being granted regarding signage for the Starbuck's Restaurant, a part of the Town and Country Planned Development, all a part of the Unified Development Ordinance and after due consideration has sent a favorable recommendation to the Council with a vote of 9 ayes and 1 nays at their March 21, 2016 meeting, and

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Noblesville, Hamilton County, Indiana, meeting in regular session, that the Unified Development Ordinance, and Ordinance No. 3-1-96 Town and Country Planned Development Ordinance, and all amendments thereto are hereby amended as follows:

SECTION 1 That the subject real estate located at 16978 Clover Road, a part of the Town and Country Planned Development and as legally described as Lot 8 in Town and Country Subdivision, is located within the zoning jurisdiction of the City of Noblesville, Hamilton County Indiana and is currently zoned PB/PD Planned Business Planned Development.

SECTION 2. That this ordinance and attached "Exhibit 1 Site Plan" indicates the location of the signs on the south elevation of the building; and "Exhibit 2 Sign Package" indicates the specific location of the proposed signs on the south elevation of the building and provides detail specifications for the words "drive thru" such as size, type, lighting source, and raceway; and the illuminated siren (logo) provides detail specifications such as size, type, lighting source, and cabinetry.

Section 3. Specific waivers granted for the placement of signage at this location include

1) Permitting two signs on the same frontage (south elevation), 2) permitting the siren (logo) to be a cabinet sign, and 3) permitting the signage to front on a parking lot and not a street.

SECTION 4. Unless a development standard, specification, guideline, and/or requirement contained in the Unified Development Ordinance or the Town and Country Planned Development Ordinance No. 3-1-96 is varied, altered, or modified by this ordinance and/or exhibits, then such development standards, specifications, guidelines, and/or requirements as specified in the Unified Development Ordinance and/or Ordinance No. 3-1-96 shall apply.

SECTION 5. This Ordinance shall be in full force and effect from and upon its adoption and publication in accordance with the law. All prior ordinances or parts thereof in conflict therewith are repealed and deemed to conform to the provisions of these amendments.

SECTION 6. (B) 13" DT CHANNEL LETTERS




